5.1 Pharmacology and Toxicology


This product is a broad-spectrum bacteriostatic with bactericidal effect at high concentration. Many Rickettsia, mycoplasma, chlamydia and spirochetes are sensitive to this product, and Enterococcus is resistant to it. For many years, because of the wide application of tetracyclines, the common clinical pathogens are resistant to tetracycline seriously, Staphylococcus and other Gram-positive bacteria and most Enterobacteriaceae bacteria are resistant. There is cross resistance between this product and different tetracycline varieties. The mechanism of action of the product is that the drug can specifically bind to the a position of 30S subunit of bacterial ribosome, inhibit the growth of peptide chain and affect the synthesis of bacterial protein.
